2. COMPOSITION / INFORMATION ON INGREDIENTS.

Part A contains; bisphenol A/F epoxy resin, CAS No.40216-08-8, 45 to 55% by weight, 2,3-epoxy propyl ester CAS No.26761-45-5, 3 to 7% by weight, dibutyl phthalate, CAS No.84-74-2, 2 to 5% by weight
OES TWA 5mg/cubic meter and inert organic pigments and extenders.

Part B contains; Isophorone diamine, CAS no. 2855-13-2 10-18%, M-xylylenediamine, CAS No. 1477-55-0, 10-18%, heterocyclic polyfunctional tert. Amine, CAS No. 15875-13-5 1-7%

3. HAZARD IDENTIFICATION.

Part A; irritating to eyes and skin, may cause sensitisation in contact with skin.
Toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

Part B; Harmful if swallowed. May cause sensitisation in contact with skin. Cause burns. Harmful to aquatic organisms may cause long-term adverse effects in aquatic environment

4. FIRST AID MEASURES.
